Think of Seville and you can't help but get lost in a dream world. Its name comes from *Ichbiliah*, an Arabic adaptation of the Roman name for the city, *Hispalis*, which first found mention in literature thanks to Julius Caesar, who referred to it in his *De Bello Civili*. According to King Alphonse X the Wise, it was founded by Hercules, the mythical demi-god. But whether or not that legend is true, Seville is a divine land.

Anyone who has had the privilege to take a walk on Sierpes Road or Doña Elvira Square, in the Alcazar's gardens or along the banks of the Guadalquivir, understands why Seville gave the colours of their palette to its famous sons, Velasquez or Murillo, and why it inspired the lyricism of its poets, Becquer or the Machado brothers. They would also understand why Don Juan – a universal myth – was born in Seville. And the reason that Don Quixote – which, according to its author, "was engendered in prison" – was born in Seville's prison, as Cervantes spent some time there following the bankruptcy of the bank in which he had deposited funds that he had collected as a tax collector in Andalusia.

Seville is a cultural melting pot. The Italica's ruins prove that Seville was not dominated by the Romans, but that it is nonetheless Roman – two great emperors saw the light of day in this great city: Trajan and Hadrian.

It is also a Moslem city, as demonstrated by the Giralda, built in 1184 by Caliph Abu Yaqub Yusuf who was inspired by the minaret of Marrakech's Koutoubiya Mosque, or the Torre del Oro that was built by the Almohad Governor in 1220, panelled with gilded azulejos – glazed tiles that shone like gold under the sun. The presence of a Jewish community is imprinted in the Barrio de Santa Cruz – the old Jewish quarters or Jewry. The Cathedral – the world's biggest Gothic temple – along with other beautiful churches and monuments, proclaims that Seville is a Christian city. And the Archivos de Indias remind us of the close links tying this ancient city to Hispanic America.

Today, Seville is one of the Southern Europe's great cities. Its inhabitants are welcoming, jovial and hardworking. The congress to be held here on October 27-31, 2009 – one of the best times of the year to visit Andalusia – will be the outcome of a skilful mix of work, immersion in the beauties of Seville's sites and good times, during which the Sevillans, with their proverbial joy for life and good humour, will help us share their traditions of feasting and celebration.

We are waiting for you in Seville.



INFORMATION COUNTRY

ENTRY FORMALITIES

If you are a national of the European Union (EU), Switzerland, Norway, Iceland or Liechtenstein, all you need is a valid passport or identity card.

) Countries for which visas are not required

Nationals from the following countries have to present their valid passports, which will enable them to stay in Spain for a maximum period of 90 days: Andorra, Argentina, Australia, Bolivia, Brazil, Brunei, Canada, Chile, Costa Rica, Croatia, El Salvador, USA, Guatemala, Honduras, Israel, Japan, Malaysia, Mexico, Monaco, Nicaragua, New Zealand, Panama, Paraguay, Republic of Korea, San Marino, Holy See, Singapore, Uruguay and Venezuela.

) For other nationalities

If you are a national from any other country, in accordance with the criteria imposed by the European Union, you will have to apply for a visa at the Consulate of Spain in your country of residence. You will also have to present a valid passport. If required, you may have to give the reason for submitting an application to enter Spain. If they deem it opportune, the Spanish authorities may also require a proof from the establishment where you will be accommodated, a confirmation of your reservation in case of a package tour, your return ticket or tour ticket, or perhaps a letter of invitation from an individual.

You may also be asked to prove that you have sufficient monetary resources to cover your expensive during your stay in Spain.

ARRIVAL

Seville airport is 10 km north-east from the Andalusian capital. On your arrival at the airport, information will be available at the UIA welcome desk (from October 25 to 27, 2009).

Santa Justa Station is just a few kilometres away from the historical heart of Seville and less than 500 metres away from Meliá Lebreros Hotel.

Daily trains are available for regional, national and European destinations.

TRANSFERS FROM THE AIRPORT

The UIA will not be providing any transfers from the airport. It takes around 15-30 minutes to reach Seville's city centre by taxi from the airport, depending on the traffic. The journey costs approximately € 25.

CURRENCY

The Euro (EUR)

Service charges are included in the prices given on restaurant menus, while tips are up to the client's judgement.

VAT, called IVA in Spanish, is calculated at 7% in hotels and restaurants; it is generally – but not always – included in displayed prices. For retail items and car rentals, the VAT chargeable is 16%.

BANKS/FOREIGN EXCHANGE

Banks are generally open to the public from Mondays to Saturdays, from 8.30 am to 2.00 pm, and foreign exchange bureaux in major cities offer visitors currency exchange services.

Foreign exchange services are also provided by a large number of hotels and travel agencies.

Payment by international credit cards is fairly widespread in Spain. The cards accepted are generally displayed at the entrances to hotels, restaurants and shops. (Caution: You almost always have to show your passport or identity card when you pay with a credit card).

Automatic teller machines (ATMs) are available throughout the city.

LANGUAGE

Spanish.

English and French are spoken in hotels, travel agencies, airports and tourist sites.

POWER SUPPLY

The electric current supplied is 220 V; 50 Hz.

Round, two-pin plug points are available, as elsewhere in Europe. In case you have any devices from the USA, kindly remember to bring a transformer/adapter.

SHOP TIMINGS

The most common opening hours for shops are: Monday to Saturday, from $9.30~\mathrm{am}$ to $1.30~\mathrm{pm}$ and $4.30~\mathrm{pm}$ to $8.00~\mathrm{pm}$

The main shopping malls and department stores are open from 10.00 am to 9.00 pm or 10.00 pm

Supermarkets are generally closed to the public on Sundays.

In restaurants, lunch is served from 1.00 pm to 3.30 pm. Dinner is served between 8.30 pm and 11.00 pm.

Several establishments offer non-stop service, particularly cafeterias and bars where tapas, "platos combinados", sandwiches and "raciones" are often served.

Nights in Spain are very lively, particularly Thursdays to Sundays. Pubs, bars and discotheques are open until 3.00 or 4.00 am and, in big cities, some even remain open until dawn.



CLOTHING

Spain is blessed with a mainly Mediterranean, temperate climate, characterised by dry summers and winters with an even temperature, and more than 3,000 hours of sunlight per year.

Seville enjoys an average temperatures of 26° C in summer and 12° C in winter, with more rain in autumn (average annual rainfall: 534 mm).

The average temperature in Seville is generally 20°C in October and 15°C in November.

Dress code for the various social events:

- Opening ceremony and welcome cocktail: Lounge/town suit (the cocktail will be held indoors, under a tent)
- Informal reception and dinner cocktail: Casual wear but bring along something warmer (the informal reception will be held partially outdoors)

 Gala dinner: Full evening dress (the reception will take place indoors)
- General excursion: Casual wear (tour of cellars where the temperature is fairly low)

TOURISM IN SEVILLE

Andalusia's capital is also the region's most fascinating city. You can't help but be charmed by its unique ambiance – elegant, ancient and proud, but at the same time friendly, personal and lively.

You will discover Seville's way of life while sauntering down its narrow lanes, its tiny squares, stopping from time to time in one of its many bars for a drink or a taste of their tapas. Also the capital of the flamenco, Seville is known for its very lively night life. Strolling through the happy crowds on a balmy evening is an unforgettable experience.

SEVILLE, A CITY OF CULTURE

It would be impossible to overlook the immense cathedral, built in the precincts of the main Almohad dynasty mosque, or the famous **Giralda**, an ancient minaret towering to a height of over 90 m. The bronze weathercock representing faith, Seville's symbol, has had pride of place atop the Giralda for over four centuries. Just south of the cathedral is the **Alcazar** (or fortress), a truly splendid and fascinating edifice associated with the lives of several famous sovereigns.

The Museo de Bellas Artes (Museum of Fine Arts) will enable you to discover paintings from Spain's Golden Age, the Barrio de Santa Cruz – the city's old Jewish quarter – will enchant you with its tiny, graceful squares decorated with flowers and orange trees, and you can watch flamenco shows with songs, dances and guitars playing at the Triana, the former gypsy district.

SPAIN'S HISTORY AND CULTURE

Spain's entry into the European Community in 1986 opened new export markets and led to an influx of infrastructure investments. Moreover, the Universal Exposition of 1992, held in Seville, led to considerable improvements in communications. Today, almost all industrial activities are concentrated in the Seville-Huelva-Cadiz triangle. Tourism accounts for over 10% of the region's economy.

The warmth of the Spanish and Spain's summer sun have long attracted tourists escaping the fogs of Northern Europe. However, the country has many things other than the beaches of the Costa Brava and the Costa del Sol to offer, no matter how beautiful they may be. A mosaic of regions as diverse as the Basque country, Andalusia, Catalonia, the mysterious Galicia or the majestic Pyrenees, Spain merits far more than one visit. This ancient empire of conquerors is rooted in a secular history immortalised by painters like Velazquez, Goya or, more recently, Picasso and Dali. Today, more than ever before, Spain is full of a cultural dynamism and celebratory spirit that are unparalleled anywhere in Europe.

PRESENTATION ON THE UNION INTERNATIONALE DES AVOCATS (INTERNATIONAL ASSOCIATION OF LAWYERS)

THE UIA'S MAJOR ACHIEVEMENTS

For over 80 years, the UIA has been defending the legal profession and stimulating international contacts, cooperation and the exchange of knowledge among lawyers, while respecting their cultural and professional diversity.

The UIA was the first lawyers' association to:

- Adopt a **Resolution on Multidisciplinary Practices** that seeks to safeguard the legal profession's fundamental values (UIA Standards for Lawyers Establishing a Legal Practice outside their Home Country).
- Adopt and present Principles to be respected by lawyers establishing a firm outside their country to the World Trade Organisation (Turin Principles of Professional Conduct for the Legal Profession in the 21st Century).
- Take a strong stand in favour of the abolishment of the death penalty.
- Establish a Code of Professional Conduct for the Legal Profession in the 21st Century, taking developments in new technologies and the challenges of globalisation into consideration.
- Publicly support the right to health as a fundamental human right.
- Adopt the Declaration on the fundamental principles of the legal profession, drafted by the major bar presidents who met in Paris in November 2005, recalling that society needs an independent legal profession and judicial system.
- Consult bar representatives from all over the world in order to **define the major challenges** facing the legal profession (The UIA Global Challenge Project).
- Be recognized as a partner of the Commission on the Legal Emancipation of the Poor (CLEP).

THE UIA'S VALUES

The Union Internationale des Avocats (UIA) was established in 1927 to:

- Promote the fundamental principles of the legal profession and the development of legal sciences in all legal fields at the international level.
- Contribute to the professional growth of its members through the exchange of information in forums established by its Commissions and Working Groups.

Today, it is an **Association that is open** to all the lawyers, all over the world, whether generalists or specialists, bringing together several thousand members and hundreds of bars, federations and associations spread out in over 110 countries.

Multilingual and multicultural, the UIA is the only major association of lawyers that has adopted French, English and Spanish as its working languages.

The UIA intervenes frequently all over the world in favour of lawyers who have either been imprisoned or are being persecuted for practising their profession.

In particular, in 2008, it followed the cases of Mr Sidhoum in Algeria, Mr Pop in Guatemala, Mrs Bapita and Mrs Nlandu in DRC, Mr Ayadi in Tunisia, Mr Moskalenko in Russia, Mr Weliamuna in Sri Lanka, Mr Goungaye in the Central African Republic, etc.


The UIA has also denounced the obstacles to the proper functioning of justice in Chad, Iraq, China, Vietnam, etc.

Since 1971, it enjoys a special consultative status vis-à-vis the United Nations and the European Council in its capacity as a Non-Government Organisation (NGO). It is represented at the main United Nations headquarters (New York, Geneva and Vienna).

The UIA also has a seat in the Consultative Councils of the International Criminal Tribunal for the former Yugoslavia.

Finally, the UIA has also been following the proceedings of the Preparatory Commission for the International Criminal Court, since its inception. Currently, it attends the sessions of the Assembly of States Parties to the Rome Statute of the Court. The UIA is a member of the International Criminal Bar's Executive Council.

This protection relies on national governments and international bodies when lawyers are threatened because of their intervention before those bodies. Legal organisations and specialized NGOs must appeal to domestic and international authorities to take their responsibility on this matter. In 2008 Avocats Sans Frontières France and other legal organisations created a Worldwide Observatory for Lawyers (Observatoire mondial au service des avocats menacés).

The Casino de la Exposición is a magnificent building in Seville that was designed by the Valencian architect, Vicente Traver y Tomás, as the venue for the 1929 Latino-American Exhibition held in Seville. The architect used aspects of the baroque style not just in the decorative details but also in the building as a whole.



The casino is located between the Glorieta de San Diego, María Luisa Park and the Plaza de España, one of the areas in which the largest number of tourist monuments can be found in the city.

Transfers will be provided between the congress hotels and the Casino. The timings will be provided at the time of the registration and will also be displayed in the congress hotels.



The horses perform dance steps and caprioles based on a choreography inspired by traditional Andalusian horse-breaking exercises. The magic


and beauty of the show, unique in its genre, will remain an unforgettable memory for spectators.

The Gonzalez Byass Cellars were established in 1835 by Manuel Maria González Angel and Robert Blake Byass, creating the family company that is now internationally renowned for its wines and brandies and for the quality that it has been able to maintain in its wide range of products.





The cellar is still managed by the 4th and 5th generations of the Gonzalez family, which has preserved the family legacy, tradition and culture of preparing and ageing wine for over 160 years.

Among the cellars that you can visit, the most characteristic is the one in which you will see barrels signed by over 200 celebrities from different countries (famous singers, sportspersons, politicians, writers, etc.)

The **Concha** cellars, built by the famous architect, Eiffel, and the **Apostoles** cellars, with their magnificent architecture, also stand out.

After visiting the cellars, you will be invited for **wine tasting** (for those who do not drink alcohol, grape juice and mineral water will be available), followed by a typical **lunch** in one of the cellars, where beautifully decorated tables will be set.

End of excursion and return to hotels between 4.30 pm and 5.30 pm.

The cost of the excursion, including transportation by bus, visits and lunch, amounts to **Euros 200** per person.

The capital of Andalusia is a compact and very pleasant city, rich in cultural heritage.

This walking tour will give you the opportunity to visit Seville's most important monuments.

Transfer from the congress hotel to the Alfonso XIII Hotel, from where you will leave in a horse-drawn carriage for the famous Plaza de España, located at the entrance to Maria Luisa Park.

An emblem of the 1929 Iberico-American Exposition, the Spanish Square is a masterpiece by Anibal Gonzalez.

A neo-Renaissance extravaganza, the Spanish Pavilion that overlooks the square with its central fountain, is laid out in a 170 m x 100 m semi-circle.



You will continue your journey by horse-drawn carriage to the Santa Cruz district, the old Jewish Quarter, which is the most representative of Seville with its small picturesque streets, its flower-covered patios and its baroque chapels.



From here, you will walk to the Alcazar to explore one of the most beautiful "jewels" of Seville, with its magnificent gardens, a harmonious mix of Mudejar and European influences. Several mosaics, a labyrinth with a geometric layout and fountains, along with all sorts of exotic plants brought from far-off lands by well-known explorers of history can be found there. An English garden

was added in the 18th century.

You can then continue to the heart of Seville to visit one the city's emblems: **the Giralda** and **the Cathedral**.

The construction of what is Europe's largest cathedral began in 1401 and lasted over a century. It was built on the site of the Great Mosque established by the Almohad dynasty at the end of the 12th century, of which the Giralda (minaret) and the Patio de los Naranjos alone remain standing to this day.

After admiring the impressive Gothic edifice and works of art

in the chapels, along with their treasures, you will be able to feast your eyes on the superb view from the top of Giralda (an enormous statue symbolising Faith that serves as a windvane for the entire complex and has given its name to the tower).



Return to the Alfonso XIII Hotel at the end of the morning and possible transfers to the Meliá Lebreros Hotel by the congress shuttles.

This tour will help you discover the Andalusian soul through the places that best symbolise its culture.



You will begin with a visit to the Basilica Macarena and its museum.

The Neo-Baroque style Basilica harbours the famous Virgen de la Esperanza Macarena, standing tall above the altar in the midst of waterfalls of gold and silver.

You can also visit the museum entirely dedicated to the Virgin's worship and

admire the chariots used during the Holy Week, particularly Macarena's superb silver platform.

You will then move on to the **Chartreuse Monastery**, located on **Cartuja** Island.



Before hosting the Expo' 92, Cartuja Island was especially known for its splendid 15th century monastery, called Santa Maria de las Cuevas. Christopher Colombus who prepared there some of his expeditions was also buried in the Monastery for a while.

Turned into a ceramics factory in the 19th century, the Cartuja factory is now a museum in which the life of the Chartreuse monks of the time has been recreated. It is also the head office of the Andalusian Centre of Contemporary Art, with a permanent and travelling exhibitions.



You will end this exploratory tour of Andalusian culture with a visit to the Flamenco Museum.

Housed in a superb 18th century residence in one of Seville's oldest streets, the museum is a must, as it reveals all the secrets of flamenco.

Established in April 2006 by the internationally-renowned danseuse, Cristina Hoyos, this private museum - unique in the world - enables its visitors to understand the complexity of the dance, song and way of life, which is still very present in Andalusia.




Cordoba is a combination of past and modernity. A **World Meritage site**, this age-old city is a living heritage of the diverse cultures that have lived there throughout history.

SUNDAY, OCTOBER 25 – SEVILLE / CORDOBA

In the 15th century, a Gothic nave was built. Deemed too small, it was turned into a major chapel and a choir in the 16th century. That is how visitors can now explore the extraordinary mix of architectures, cultures and religions in the **Mezquita-Cathedral**.

On the way back to the hotel, located in the "Juderia" (Jewry), at the end of the afternoon, you will visit the tiny Synagogue, one of the only three that have survived in Spain from that period (the other two are in Toledo).

Time to settle down in your rooms and free time before dinner.

In the early evening, you will walk to the Almudaina restaurant located very close to the hotel for a typically Andalusian dinner.




